Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criteria are:

- a) The Firm's general experience and overall competence, including relevance of the applicant firm's area of core business to the assignment envisaged;
- b) Firm's good reputation, strong institutional capacity and capability in terms of technical, managerial, expertise, quality management system, number of technical staff and financial soundness etc.
- c) The extent of specific experience in assignments of similar nature and complexity in construction management and supervision of substations (132/33 kVs and above), including review of design, supervision of EPC contractor's quality, schedule, environmental, safety and health compliance, verification of equipment quality, certification of variation orders etc. (relevant completion certificates and/or letters of recommendations from former clients to be provided if available);
- d) The extent of specific experience in assignments of similar nature and complexity in construction management and supervision of substations in sub-Africa region would be a plus.
- e) Evidence and certification of quality and environmental management

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "**Procurement Regulations for IPF Borrowers**" **July 2016 ("Procurement Regulations")**, setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Procurement Regulations.
